(3) One-Day Workshop on Revised Syllabus of B. Com-Part-II (Sem.-III&IV) of Corporate Accounting Under CBCS Pattern.

Shivaji University sponsored one day workshop on Revised syllabus of B. Com-II (Sem.-III&IV) of Corporate Accounting paper-I &II under CBCS pattern was organized on 28th August,2019. The total 89 subject teachers form different colleges participated in the workshop.

Principal Dr. V. A. Mane introduced about the workshop. He highlighted on the theme and objectives of workshop in his introductory speech. He expressed that in the era of computer-based accounting systemic there is an urgent need to change the syllabus.
